THE SOCIETY MAKES A COMMITMENT TO EACH ANIMAL, PROVIDING THEM WITH OUTSTANDING HEALTH CARE, QUALITY FOOD AND TOYS, PLENTY OF SOCIALIZATION, EXERCISE, AND RELAXATION, AND FOSTER CARE FOR ANIMALS NOT YET READY FOR ADOPTION BECAUSE THEY ARE TOO YOUNG OR TOO SICK.

THE FERAL CAT TRAP-NEUTER-RETURN PROGRAM, BASED ON SUCCESSFUL MODELS ACROSS THE COUNTRY, HAS STERILIZED MORE THAN 15,000 FERAL CATS IN ITS THREE YEARS OF EXISTENCE. EACH CAT IS SPAYED OR NEUTERED, GIVEN PAIN MEDICATION, AND VACCINATED AGAINST ALL MAJOR FELINE DISEASES. THE FERAL CAT TRAPPERS (ALL VOLUNTEERS) ARE THE LIFEblood OF THE PROGRAM. THE PLUMMETING EUTHANASIA RATE AT THE CITY-RUN SHELTER IS DUE IN LARGE PART TO THE EFFORTS OF THE SOCIETY'S FERAL CAT PROGRAM.
